BOARDING AGREEMENT

In consideration of Kathryn Jensen (d/b/a Katie's Kennel, Inc.) boarding my/our pet(s) the undersigned agrees and represents as follows:

1. To pay Katie's Kennel, Inc. the total accrued for each night my pet is/are boarded. The total for their stay will be determined by what time I pick them up on their last day. To pay Katie's Kennel, Inc. the total accrued for each day my pet is/are participating in daycare.
2. I represent my pet(s) is/are free of all diseases and has/have had all required shots and vaccinations (**DHLPP, RABIES, BORDATELLA**). I further understand and agree that in admitting my pet(s) to Katie's Kennel, Inc. Katie has relied on my representation that my pet(s) is/are in good health and have not harmed or shown aggressive or threatening behavior towards any person or any other dog.
3. To supply all food/medicine which may be necessary during the term the pet(s) is boarded. **If your dog runs out of food or you forget their food, a \$40 charge + the cost of the food will be applied to your final bill.** Please be sure to pack the right amount of food, plus extra.
4. In case there is an emergency and I cannot be reached I authorize you to contact the emergency contact I have given to make decisions on the care of my pet(s). If the person cannot be reached, the undersigned leaves it to the discretion of Katie's Kennel, Inc. to respond to the emergency and the undersigned agrees to be responsible for **ANY AND ALL CHARGES INCURRED**.
5. To be solely responsible for any harm caused to or by my pet(s) while my pet(s) is/are boarded at Katie's Kennel, Inc. I understand the risk(s) of placing my dog(s) in a setting with multiple dogs at a time and that it is my responsibility to fully research these risks. These risks include but are not limited to: nips, bites, scratches, illness, injury, allergies, or stress related illness (diarrhea, dehydration, UTI's), etc. I understand that while Katie's Kennel, Inc. screens all of their guests, dogs are still animals. By having multiple dogs together, accidents can happen and illness' can occur. It is my choice to place my dog in that type of environment. **I understand I am solely financially responsible for any veterinary care, for any reason, needed during or after their stay.**
6. I understand that my pet (s) will be in a setting with multiple dogs, exposed to other dogs and their odors, and will spend a majority of their time outside playing in all weathers. I understand it is my responsibility to request a bath for my dog if desired. If my dog has an accident, or requires a bath due to his own odors disrupting the day to day activities of those it's around, a bath will be given and the appropriate charges will be added to my bill.

7. In case of behavior issues or health issues and my pet(s) need(s) to be removed from the facility, I authorize you to contact my emergency contact to come and pick up my dog(s) and/or anyone else I have specified to Katie's Kennel, Inc.

8. I have read and agreed to Katie's Kennel, Inc.'s Policies and Procedures.

9. To release Katie's Kennel, Inc. to include all employees and owners of the premises in which Katie's Kennel, Inc. is located and to indemnify each of them for any claim made against them in connection with the boarding of my pet(s).

10. Katie's Kennel, Inc. has permission to post pictures of my pet(s) on their business Facebook page along with their business website.
